- S&P 500 is up 16.24 %.

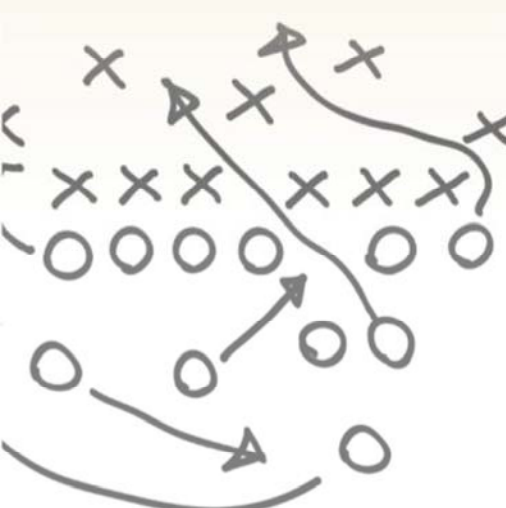
The last week's sector movers were as follows:
